

# Dodatok k Ochrane osobných údajov

Platný od 25.05.2018

Ochranu vašich osobných údajov berieme vážne. Je pre nás dôležité, aby vaše údaje, získavané na stránke wisomm.com, boli v bezpečí a aby boli využívané iba na také účely, s ktorými súhlasíte. Táto časť Podmienok ochrany súkromia definuje a vysvetľuje aké vaše osobné údaje uchováваме, ako ich zbierame, používame a zdieľame a za akým účelom. Ďalej ako sa môžete domáhať svojich práv a ako vaše osobné údaje môžete spravovať.

Od 25.mája 2018 sú vaše údaje spracúvané v súlade s Nariadením Európskeho parlamentu a Rady EÚ 2016/679 z 27.apríla 2016 o ochrane fyzických osôb pri spracúvaní osobných údajov a o voľnom pohybe takýchto údajov (GDPR) a v súlade so zákonom č.18/2018 Z.z. o ochrane osobných údajov.

## 1. Správca osobných údajov

Správcom vašich osobných údajov je firma Kalreal, s.r.o. so sídlom: Jantárová 33, 85110 Bratislava, Slovensko, IČO: 36 753 955 (zapísana v Obch.registri Okresného súdu Bratislava I, Oddiel Sro, vložka č. 45119/B ako vlastníka Wisomm.com. Konateľom je Juraj Kalafut.

Spoločnosť sa zaoberá rôznymi aktivitami ako aj prevádzkovaním služby Wisomm.com.

## 2. Aké osobné údaje, na aké účely a ako dlho spracováваме?

Za osobný údaj je považovaná akákoľvek informácia, ktorá sa vás týka, a na základe ktorej ste pre nás ako fyzická osoba určiteľným subjektom.

Vaše osobné údaje ako e-mailová adresa, meno, priezvisko a užívateľské meno, ktoré ste zadali počas registrácie na stránke wisomm.com/sign-up, využívame na sprostredkovanie služby spojenej s vykonaním objednávky a zakúpením vstupeniek (na komunikáciu v prípade potreby ohľadom nákupu vstupeniek, či na poradenské služby – customer service), na identifikáciu a verifikáciu majiteľa takto zakúpených vstupeniek na mieste konania akcie organizátorm tejto akcie, z dôvodu zabráneniu zneužitia takto zaukúpených vstupeniek tretou osobou (ide o osobné údaje ako užívateľské meno, výnimočne meno a priezvisko), Váš e-mail používame na zasielanie tipov na akcie a noviniek, oznamov týkajúcich sa našej služby, v prípade vašej výhry v jednej z online súťaží (do ktorej prihlásenie je plne dobrovoľné a vykonané pridaním komentára, hodnotenia, či uložením si vína do sekcie Moje víno na stránke wisomm.com).

Zároveň uchováваме vašu IP adresu, ktorú vám pridelil váš poskytovateľ internetu a ďalšie údaje súvisiace s návštevou portálu a cookies služieb (tieto údaje nespracováваме a v žiadnom prípade neukladáme mimo možností služby Google Analytics, tá ma na starosti ich ochranu a správu, tieto údaje a práca s nimi, je len v štatistickej rovine, pomáha nám a naším partnerom (organizátorom akcií) určiť, ktoré investície do marketingu sú pre nás najefektívnejšie a ako vylepšiť naše služby (na základe informácií z akej stránky, zdroja, cez aké kanále ste prišli na portál, ako dlho a aké podstránky ste prezerali, kde ste portál opustili, dostupné demografické údaje, lokalizačné údaje atď.) údaje sa nevyužívajú napríklad na online marketing ani remarketing služby), ktorých použitie ste akceptovali na základe registrácie. Informácie súvisiace s návštevou portálu uchováваме aj pomocou služby Facebook pixel, kód ktorý zaznamenáva stránky a podstránky, ktoré ste navštívili na našom portáli a kedy, a spracováva ich v súvislosti s vyhodnocovaním platených kampaní na Facebook.com. Tieto údaje taktiež niesu využívané na následné marketingové activity ako profilovanie s cieľom remarketingu alebo vytváranie custom audience. Ďalej vaše osobné údaje odoberá služba Google Adwords (na cielenie kampaní podľa rôznych dát o vašej návšteve portálu, vykonanie konverzií, sledovanie interakcií na stránke).

Vaše osobné údaje uchovávam po dobu 10 rokov od registrácie. Ak právne predpisy (účtovné, daňové apod.) vyžadujú inak, rešpektujem zákonnú lehotu, prípadne po kratšiu dobu, ak požiadate o vymazanie vašich údajov pred uplynutím tejto lehoty.

Pri spracúvaní vašich osobných údajov využívam profilovanie, a to za účelom skvalitnenia služieb a lepšiemu prispôbeniu obsahu portálu a pozvánok na akcie (na základe vášho oprávneného záujmu).

### 3. Poskytovanie osobných údajov tretím stranám

V prípade vykonania objednávky a zakúpením vstupeniek, poskytujeme vaše meno, priezvisko a e-mail spoločnosti GOPAY s.r.o. - inštitúcie elektronických peňazí, ktorá zabezpečuje bezpečnú online platbu objednávky a prevod peňazí s Vášho účtu na náš účet v tejto inštitúcii. Bez týchto osobných údajov nieje možné objednať a platbu vykonať a priradiť k vašej osobe.

V prípade overenie a identifikácie objednávok vstupeniek na mieste konania akcie, ako aj za účelom vykonania vyúčtovania medzi Wisomm.com a organizátorom akcie, sú údaje vami vykonanej objednávky (užívateľské meno, číslo objednávky a GoPay ID objednávky, v prípade vášho osobného povolenia alebo vyžiadania aj meno a priezvisko) poskytnuté organizátorovi akcie (jeho meno a kontaktné údaje sú uvedené v popise akcie na wisomm.com ako aj na zakúpenej elektronickej vstupenke).

Pre ochranu vašich osobných údajov zadaných na wisomm.com používame vysokú formu zabezpečenia - Secure Sockets Layer (SSL) software, tak aby nemohlo dôjsť k zneužitiu informácií.

Spracovanie Vášho osobného údaju - e-mailová adresa, má na starosti spoločnosť **MailChimp Inc.** so sídlom v USA. Pravidlá ochrany súkromia vid': <https://mailchimp.com/legal/privacy/>

V prípade, že z nejakého dôvodu dôjde k zmene alebo rozšíreniu zoznamu spracovateľov vašich osobných údajov, ubezpečujem vás, že aj v týchto prípadoch budem dbať na maximálnu ochranu vašich osobných údajov (v súlade s Nariadením).

Okrem vyššie uvedených spracovateľov (ktorí sú viazaní patričnými zmluvami a považujú vaše osobné údaje za dôverné) **neposkytneme** vaše osobné údaje žiadnym tretím stranám, pretože ich považujem za citlivý a dôverný údaj a takým spôsobom s nimi narábam. Poskytnutie vašich údajov štátnym orgánom je len na základe platných zákonov alebo právoplatných súdnych alebo úradných rozhodnutí v súlade s právnymi predpismi SR.

Tieto údaje nepoužívame na žiaden iný účel. Váš súhlas môžete kedykoľvek odvolať a váš komentár bude vymazaný, alebo ho môžete vymazať samy.

Ak si uložíte víno do sekcie "Moje víno" na našom portáli, stlačením tlačidla "Moje TOP" alebo "Chutí mi" dávate súhlas so zverejnením vami uvedeného údaje a jeho spracovaniu pre profilové, štatistické a marketingové účely a sprostredkovaním tohto údaje (názov vína, názov vinárstva a užívateľské meno) vinárovi (ktorého víno ste si uložili, jeho meno a kontaktné údaje sú uvedené v profile vinárstva na wisomm.com) prostredníctvom portálu wisomm.com.

Ak pridáte hodnotenie na portáli, stlačením tlačidla "Pridať" dávate súhlas so zverejnením vami uvedených údajov v hodnotení a ich spracovaniu pre štatistické účely a vyhodnoteniu súťaží na portáli wisomm.com. (ide o údaje úroveň hodnotenia a užívateľské meno).

## 5. Vaše práva

Ako dotknutá osoba máte právo na –

**prístup k údajom**, ktoré o vás uchovávam máte prostredníctvom sekcie "Môj účet", kde nájdete osobné registračné údaje ako aj svoje vykonané objednávky, svoje komentáre v konkrétnej prezentácii organizátora ktorému boli pridané, uložené vína nájdete v sekcii "Moje víno", všetky tieto údaje môžete spravovať a vymazať. Prípadne máte právo na kópiu spracovávaných údajov,

**opravu alebo doplnenie údajov**, ak sú uvedené nesprávne alebo neúplne,

**vymazanie údajov**, ak skončí lehota na ich uchovávanie, alebo kedykoľvek ak o ich vymazanie môžete požiadať cez e-mail [info@wisomm.com](mailto:info@wisomm.com), alebo sami prostredníctvom sekcie "Môj účet" a stlačením tlačidla "Vymazať účet" či "Vymazať" pri vašom komentári alebo vašej objednávke. Vaše údaje budem uchovávať a spracovávať aj naďalej, ak to vyplýva zo zákonných povinností (napríklad účtovných alebo daňových).

**prenos údajov** k inému prevádzkovateľovi, ak o to písomne požiadate,

**vznesenie námietky** voči spracovaniu vašich údajov, ak som ich spracovával na základe oprávneného záujmu (podľa čl.6, odst.1, písm.f) Nariadenia).

Všetky vaše požiadavky spracujem **do 48 hodín** od ich prijatia.

Dozorným orgánom nad spracúvaním osobných údajov je Úrad na ochranu osobných údajov SR (<https://dataprotection.gov.sk/uoou/>). V prípade, že vašu žiadosť nevybavím do 1 mesiaca od požiadania, alebo nebudete spokojní s jej vybavením, môžete sa obrátiť na tento úrad s vašou sťažnosťou.

## 6. Zabezpečenie vašich údajov

Vaše osobné údaje chránime v maximálnej možnej miere, pomocou dostupných technológií (Secure Sockets Layer (SSL) software), ktoré zodpovedajú stupňu technického rozvoja. Prijali sme všetky aktuálne dostupné opatrenia, aby sme vaše osobné údaje ochránil a zamedzil ich zneužitiu, poškodeniu alebo zničeniu.

## PRIVACY POLICY

1. This Privacy Policy as a separate document concerning personal data protection represents an integral part of the General Terms and Conditions of Use of Services at Wisomm.com ("**Terms**"), stipulating mutual rights and obligations between the company KALREAL, s.r.o. – operator of the website Wisomm.com, Wisomm mobile apps and other related online platforms ("**Wisomm**") – and the respective users of the services provided through Wisomm platforms. The Privacy Policy shall be construed and applied in the context / in consideration of the Terms. Please read the Terms first before accepting this Privacy Policy. The Terms and the Privacy Policy form a Service Agreement between Wisomm and an individual User of the services provided through Wisomm platforms ("**Agreement**").
2. Capitalized terms used in this Privacy Policy but not defined herein shall have the meanings ascribed to them in the Terms.
3. By performance of the Agreement, Wisomm assures protection of personal data of the User who is a natural person and the User's privacy in accordance with the provisions of this Privacy Policy and with applicable legal regulations governing the Agreement.
4. Personal data  
By the Registration (by entering data in the registration form) or later by modification of data in the User Account, the User is asked to submit to Wisomm the following data: username (nick), valid User's email address, password, name and surname. This allows the User to access / administer the User Account and use the Services on the Platforms (as per the Terms). Collectively, some of these data, including any additional data submitted by the User in the User Account or in the User's profile on the Platforms ("**Personal Data**"), may be considered as the User's personal data which are subject to a special legal protection.  
  
The Personal Data submitted by the User to Wisomm are deemed to be true and accurate; Wisomm shall not be obliged to verify them in any way, nor does Wisomm bear any responsibility in case that the Personal Data are proved to be untrue or inaccurate.
5. User's Consent  
By accepting this Privacy Policy, the User provides his/her express consent with processing of the Personal Data by Wisomm in accordance with the subsequent provisions of this Privacy Policy ("**User's Consent**"). The User's Consent is provided of his/her free and earnest will, free of any charge and without any time limitations. The User's Consent may be withdrawn by the User at any time by e-mail sent to Wisomm (Wisomm's e-mail address listed in the respective Clause of the Platforms), however based on such withdrawal of the User's Consent Wisomm may cease providing the Services to the User and terminate the Agreement with the User, with immediate effect.
6. The Personal Data may be processed by Wisomm in electronic form in an automated manner or in printed form in a non-automated manner. Regardless of the location of the User, the Personal Data will be processed by Wisomm in the territory of the Slovak Republic, unless otherwise is stipulated herein.
7. Purposes of collection and use of the Personal Data  
The Personal Data (or certain part of them) may be used by Wisomm for the following purposes:
  - (a) administration / maintenance of the User Account;
  - (b) processing of Reservations, Prepayments and distribution of Tickets in accordance with the Agreement;
  - (c) performance of other Wisomm's obligations under the Agreement;
  - (d) User Service;
  - (e) other communication with the User (via email or User Account) in relation to the Services, Events, Reservations, Tickets, User Reviews, offers, invitations, newsletters, etc.;

- (f) analytical purposes of Wisomm, aimed at improving functionality and quality of the Services and enhancing user experience on the Platforms;
  - (g) marketing purposes of Wisomm, i.e. sending messages about the Services and other Wisomm's activities, including information about special offers of Wisomm for the User, promotion / advertisement information about Wisomm's Services and/or Providers' Events and/or third party products or services, sending other business messages via electronic means according to applicable legal regulations; the User's Consent with regard (only) to these marketing purposes may later be withdrawn through unsubscribing from Wisomm's marketing communication (using unsubscribe link present in the respective Wisomm's emails to the User);
  - (h) market research – Wisomm may from time to time ask the User to take part in a market research; use of any additional personal details (other than the Personal Data) submitted by the User within a market research is subject to a special (additional) consent to be requested from the User;
  - (i) detection and prevention of fraud and other illegal or unwanted activities and/or any other use of the Personal Data as required by applicable legal regulations or by relevant law enforcement and other governmental authorities insofar as it is required by law.
8. The Personal Data shall not be published on the Platforms nor shall they be made available to public by any other means, except for the username (which will be used to identify the User while using the Platforms, e.g. by posting User's comments, User Reviews, etc.) and any content posted / published on the Platforms by the User himself/herself (e.g. within the User Reviews). The Personal Data shall not be transferred to third parties unless otherwise is approved by the User, either in this Privacy Policy or separately.
9. With regard to processing of the Personal Data by Wisomm, the User may, in particular:
- (a) ask Wisomm for explanation / information on processing of the Personal Data;
  - (b) ask Wisomm for list of processed Personal Data of the User;
  - (c) ask Wisomm about the source of particular Personal Data,
  - (d) ask Wisomm for correction of errors in the Personal Data,
  - (e) ask Wisomm for blocking of such incorrect Personal Data in case of withdrawal of the User's Consent,
  - (f) request discarding of the Personal Data if the User believes that Wisomm performs processing of the Personal Data in violation of this Privacy Policy or applicable legal regulations.
10. If the User requests information on processing of the Personal Data, Wisomm is required to provide the User with such information. In order to prevent unauthorised individuals from accessing the Personal Data, Wisomm may (if necessary) ask the User to present relevant proof which is sufficient to verify the User's identity. Also, Wisomm has the right to request a reasonable payment for providing such information, corresponding to actual costs incurred by Wisomm in this respect.
11. Processing of the Personal Data shall be ceased upon withdrawal of the User's Consent or upon termination of the Agreement (i.e. also upon closure / cancellation of the User Account). Thereupon Wisomm shall ensure that all Personal Data of the User stored on the Platforms and/or other storage means / devices are discarded.
12. When processing the Personal Data as per this Privacy Policy, Wisomm shall comply with the respective legal regulations applicable in the Slovak Republic (i.e. the country in which the registered office of Wisomm is located). Any reference to applicable legal regulations in this Privacy Policy means the legal regulations of the Slovak Republic as well as applicable European data protection laws. For purposes of Personal Data protection, Wisomm is considered as operator of an information system containing the Personal Data submitted by the respective registered Users of the Platforms, based on their consent provided by accepting this Privacy Policy. In order to safeguard the Personal Data and to prevent any unauthorised access and/or misuse of the Personal Data, Wisomm uses appropriate security procedures and technical and physical restrictions for accessing and using of the Personal Data.
13. When visiting the Platforms, even if the User does not make a Reservation, Wisomm may collect certain information, such as the User's IP address, information about the User's web browser, operating system, application version, language settings and pages that have been shown to the User. If the User uses a mobile device, Wisomm might also collect data that identify the User's mobile device, device-specific settings and

characteristics and latitude/longitude details. When the User makes a Reservation, Wisomm system registers through which means and from which particular Platforms the Reservation is made.

#### 14. Use of cookies

By accepting this Privacy Policy, the User acknowledges and accepts the use of cookies and/or similar technologies at the Platforms. The aim of cookies is to collect certain anonymized information about the Users of the Platforms and their activities at the Platforms in order to improve the user experience on the Platforms and the overall quality of the Services provided to the Users, e.g. by recognising the User across the Platforms, remembering login information, the Platforms preferences and other customization functions as available.

Cookies are stored by the Platforms on the User's computer or mobile device, in the corresponding file as set in the User's web browser; they can be found in web browser settings. Cookies used by the Platforms have varying lifespan; maximum lifespan set on some of them is five years from the User's last visit to the Platforms. The User can erase all cookies from web browser at any time.

The User is able to modify the use of cookies by adjusting the respective web browser settings (e.g. to set which cookies to accept / reject). However, the Platforms do not support "Do Not Track" browser settings. Opting out of an online advertising network does not mean that the User will no longer receive or be subject to online advertising or marketing analysis; it means that the network from which the User opted out will no longer deliver ads tailored to the User's web preferences and browsing patterns.

The User may choose to disable cookies or restrict the use (acceptation) of cookies, while the User can still access and use the Platforms and Wisomm's Services. However, in such case the functionality of the Platforms and the Services may be affected, as the User may not be able to use the Platforms' cookie-dependent features.

#### 15. Types of cookies

The Platforms use the following types of cookies:

- (a) Technical cookies are necessary for proper functioning of the Platforms, including an advanced and user-friendly website that adapts automatically to Users' needs and wishes, and the online reservation system.
- (b) Functional cookies are used to remember Users preferences and to help to use the Platforms efficiently and effectively, for example by remembering preferred currency and language, searches and events viewed earlier; functional cookies are not strictly necessary for functioning of the Platforms but they add functionality for the Users and enhance user experience.
- (c) Analytics cookies are used to gain insight into how the Users use the Platforms, to find out what works and what doesn't, to optimise and improve overall quality of the Platforms. Gathered data include: viewed web pages, which referring/exit pages Users entered and left from, which platform type Users used, date and time stamp information and details such as the number of clicks made on a given page, mouse movements and scrolling activity, search words, text typed while using the Platforms. Analytics cookies may be used as part of online advertising campaigns to learn how the Users interact with the Platforms after they have been shown an online advertisement – which may include advertisements on third-party websites. However, data gathered in such way are strictly anonymous.
- (d) Commercial cookies are third-party cookies used to display personalised advertisements on the Platforms and on other websites. This is called "retargeting," and it is based on browsing activities, such as the destinations the Users have been searching for, Events they have viewed and the prices they have been shown. Commercial cookies may also be used by selected third parties to display their products and services through the Platforms.

#### 16. Third-party commercial and analytics cookies

Wisomm may use services of trusted and recognised online advertising and marketing companies and/or other third-party providers for analytical purposes, which requires placement of cookies by these third-party providers. In order to control the collection of data for analytical purposes by Google Analytics, you may want to visit the following link: [Google Analytics Opt-out Browser Add-on](#).

#### 17. Access to cookies

Only Wisomm has access to cookies used / placed by the Platforms. Cookies placed by third parties (as per this Privacy Policy) can be accessed by these third parties.

18. Use of web beacons

Besides cookies, Wisomm may use web beacons. Web beacon is a tiny graphic image of just one pixel that's delivered to user's computer either as part of a web page request or in an HTML email message. Either directly or through service providers, Wisomm uses these pixels as part of online advertisements either on the Platforms or on third-party websites to learn whether a user who is being shown an online advertisement also makes a reservation, to track conversion with partner websites and to analyse the traffic patterns of the Users to optimise the Services provided to the Users.

19. Use of mobile devices

Wisomm offers free apps for a variety of mobile devices as well as version of the regular website optimised for mobile devices. The apps and website for mobile devices process the User's data in the same way as regular website, while they also allow the User to use location services to find Events nearby. Wisomm may send to the User push notifications with information about the Reservations / Events.

20. Use of social media

Wisomm uses social media to promote the Events or Providers and to promote, improve and facilitate Wisomm's Services. For this purpose, Wisomm may use User Reviews (or any part thereof) or any other content posted by the User on the Platforms (for public, outside of the User Account) by publishing such content posted by the User on social media.

21. Sharing of the User's data with third parties

The Personal Data and/or other data of the User may be shared with third parties in the following cases:

- (a) Wisomm may later authorise a third party to arrange processing of the Personal Data on behalf of Wisomm; such third party shall then be specified as a processor of personal data in this Privacy Policy (as amended) published on the Platforms.
- (b) With regard to processing of the User's payment by the respective Payment Processor (Clause 5.3 of the Terms), Wisomm may submit the User's email address to such Payment Processor.
- (c) With regard to Reservation of Tickets to an Event, Wisomm submits to the relevant Provider organizing the Event the username and other details of the Reservation (date of Reservation, Reservation number - 'GoPay Order ID'). If necessary (with regard to the Reservation, User's attendance of the Event, User's questions or requests about the Event), Wisomm may submit to the Provider the User's email address.
- (d) If Wisomm's User Service or any part of the Services is outsourced to a third party, the Personal Data may be shared with such third party who is obligated to secure Personal Data protection and to refrain from use of the Personal Data for any unauthorised purpose.
- (e) Wisomm works with its business partners around the world to promote, advertise or distribute Events (posted on the Platforms) and to help Wisomm's business partners promote, advertise or distribute their own wine tasting events and/or related products and services. This may mean that their services are integrated into the Platforms or they are enabled to show customised advertisements on the Platforms – and the same applies to Wisomm's advertisements on their websites and platforms. Certain business partners may receive your personal data from us if requested by you. Based on the User's data collected by Wisomm, relevant individualized offers of products or services may be shown to the User on the Platforms (including mobile apps) or on third-party websites or other platforms (including social media sites).

The User acknowledges and agrees that in the course of sharing of the Personal Data by Wisomm in accordance with this Clause 21, these specific Personal Data may be transferred from the Slovak Republic to other countries, either to other EU member states or third countries (non-EU countries guaranteeing adequate level of protection of personal data).

22. In addition to the Personal Data referred to in Clause 21 above (collected and then shared by Wisomm), the User may be asked by the Payment Processor or by the Provider respectively for submission of other User's data, payment information (e.g. credit card details), etc. Such collecting and processing of the User's data is arranged exclusively by the third party asking for the data, with no involvement of Wisomm and without

application of this Wisomm's Privacy Policy. The User acknowledges that such collecting and processing of the User's data is subject to relevant terms and conditions applicable to the services of such third party (e.g. Payment Processor).

23. The User fully understands and agrees to be bound by this Privacy Policy as modified and/or amended by Wisomm from time to time. Wisomm reserves the right to make any modifications and/or amendments of this Privacy Policy at any time in the course of duration of the Agreement. Any amendment of the Privacy Policy will be published on the Platforms whereupon the Privacy Policy as amended shall become effective. The User shall also be notified on the fact that the Privacy Policy has been amended via email; such message will also include the link to the amended version of the Privacy Policy. The User shall be responsible for reviewing any amendments of the Privacy Policy and for being acquainted with the currently valid and effective Privacy Policy (as amended) each time the User uses the Services or Platforms. The User acknowledges Wisomm's right to modify and/or amend the Privacy Policy from time to time as stipulated herein. If any amendment of the Privacy Policy is not acceptable to the User, the sole recourse for the User is termination of the Agreement in accordance with the Terms.
